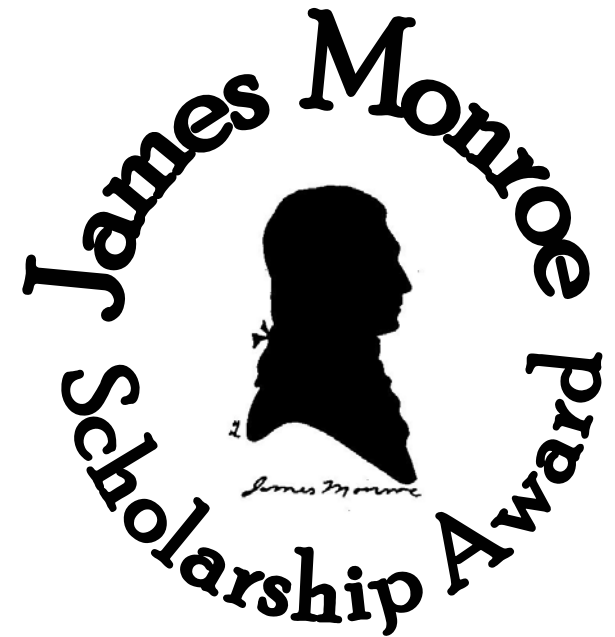

This year, the James Monroe Foundation offers high school juniors and seniors the opportunity to win one of three scholarship awards by entering our Scholarship Award writing competition. The 2006 topic is:

James Monroe: Guardian of a Free Hemisphere

- The applying student must be a junior or senior in a public, private or home-school high school program.
- The first page **must** include the following: first and last name, title of paper, grade, name of high school, state, phone number, address and e-mail address.
- The paper may or may not be an assigned part of a formal class or registered home school assignment.
- The paper must be between 1250-1500 words in length.
- The paper must be documented appropriately with **either** footnotes or endnotes **and** a bibliography.
- Any participant under age 18 must have their parent/guardian print, sign and return the JMSA Consent Form located at www.jamesmonroe.org/consent
- The paper **must** be submitted via e-mail as a MS Word attachment to: scholarship@monroefoundation.org

All submissions must be received electronically by March 12, 2006, to be considered in the competition. Winners will be selected and notified by April 9, 2006. A panel of distinguished Monroe scholars and special lists will review all submissions for strength of thesis, clarity, research applicability, style, creativity and treatment of the chosen topic. The paper should be reflective, demonstrating hard work, sound judgment, and sensitivity to the complexities of the subject's issues. Additionally, the paper should contain very few errors, none of which serves to undermine the effectiveness of the paper for well-informed readers. All submissions must be original work.
